Request:

For my dissertation subject I would like to undertake a study of HMO properties and the effectiveness of current standards/guidance documents that are applied to them, for this I will need to analysis recorded data on these properties from the event of a fire in the area of London. The data I am looking for will include:

- total number of residential property fires in London over the last 10 year (on a year-by-year basis i.e. 2012, 2013, 2014, 2015 etc)
- how many of these residential property fires where registered HMO properties (on a year-by-year basis i.e. 2012, 2013, 2014, 2015 etc)
- How many of these residential property fires where HMO or believe to be HMO properties but not registered for this usage (on a year-by-year basis i.e. 2012, 2013, 2014, 2015 etc)
- IF recorded where the HMO properties considered of a suitable standard for their intended use with regards to fire compartmentation and life safety systems installed.
