Request:

I am looking for arson incidents the Woodland Walk BR1 5QW over the past decade.

Response:

By way of background, the LFB do not decide if fires are attributed to the criminal act of deliberately setting fire to property (arson). This would likely be something done by the Metropolitan police.

However, attending crews do record their supposed cause/motive of **primary fires** on our Incident Management System (IMS). One of the primary fire categories for motive is 'deliberate'. Deliberate fires are those where a fire is suspected to have been started deliberately (but not always with a malicious intent), for example some fires are started by children.

The motive reflects the nature of the 'uncontrolled burning'. For example, whilst a bonfire will be started deliberately, if it gets out of control and sets light to a nearby shed, the motive will be recorded as accidental; the uncontrolled shed fire was an accidental consequence of the bonfire.

The LFB do not record the cause/motive for **secondary fires**. Secondary fires are less serious fires and less information is recorded about these fires. Secondary fires are the majority of outdoor fires including grassland and rubbish fires; unless they involve casualties or rescues, property loss or unless five or more appliances attend. Fires in derelict buildings are recorded as secondary fires.

I have searched our Incident Management System (IMS) and found the following fire incidents attended in Woodland Walk or (and nearby Nubia Way) since 2012:

The motive of the secondary fires in the table above is not recorded by the LFB. Neither of the two primary fires were recorded as deliberate.

The type of incident (i.e. fire, false alarm, special service);

The location of incident (Borough, fire station ground, postcode, USRN, latitude/longitude);

How long it took first and second fire engine (pump) to arrive at incident;

Where the fire engine(s) were deployed from;

The number of fire engines that attended the incident;

The length of time the fire engines stayed at the incident;

The notional cost of the LFB attending the incident.
