Incident recording software

We use our own system, IMS (Incident management System) There are no licensing requirements.

Hydrant Management software

We use our own system, Farynor There are no licensing requirements.

Risk management software We use our own system, ORD (Operational Risk Database). There are no licensing requirements.

Geographical information system (GIS) We use the Cadcorp SIS WebMap product with a corporate (all user) licence.

Gazetteer software

We currently use the ESRI ArcGIS Desktop and LocatorHub products. This is a server based product installed on two servers with two corresponding licences

Mobile Data Terminal software

We currently use the Airbus Defence and Space, SCResponse product installed on 340 devices with individual licences.
