Request:

Documents relating to reports about, or inspections of, unregistered schools (which may also be referred to as "yeshivas")

- in Hackney over the past three years
- in Haringey over the past three years

I would expect the names of any individuals to be redacted, but would expect the names and addresses of the schools to be included (I was given this information via FOI in 2017).

I know you have held this information in the past, as it was referred to in this article published in the Independent - and later provided to me via FOI:

"Hackney London Fire Brigade Commander Steve Dudeney telling the committee there had been fires at five of 32 suspected illegal schools identified by the council, a figure he described as "high".

Separately, the fire brigade found evidence children may be sleeping at three of the illegal schools."
