I'm emailing from Ashford Place – we're a long-standing charity in Brent and provide a range of services to local residents. We're hoping to do some future work on fire prevention and safety with our service users, and as part of this I'm trying to get a better sense of the relevant fire incident data in Brent. I've been using the London Fire Brigade Incident Records datasets as my starting point – however, it looks as though the two files listed there are both almost identical, with neither including post-2017 data. I wonder if you might be able to assist with this? Additionally, if you have any other Brent specific data relating to dwelling fires, I would be very keen to see it, if at all possible.
