Executive Summary

This report recommends a permanent appointment to the role of Director for People.

Recommended decision

That the London Fire Commissioner appoints Sally Hopper as the Director for People.

1 Introduction and background

- 1.1 Following the departure of the Director for People in May 2023, recruitment for a permanent replacement began in October 2023, however, the Brigade was unable to recruit permanently to this role at that time. Interim leadership was put in place and an additional executive search took place from August 2024. Korn Ferry undertook the executive search for this position.
- 1.2 Overall, 48 applications for the vacancy were received and reviewed with four candidates being interviewed by the London Fire Commissioner (LFC), Chief People Officer, Transport for London, Chair of LFB's Advisory Panel and Executive Director for Strategy and Communications at the Greater London Authority. Candidates also took part in a stakeholder panel made up of Directors, colleagues in the People directorate and a representative from LFB's Community Forum. In addition, they completed an equality, diversity and inclusion exercise.

2 Recommendation from the panel

2.1 The panel's recommendation is that Sally Hopper is appointed as Director for People.

3 Objectives and expected outcomes

3.1 The appointment of a new Director for People will provide the LFC with permanent and stable leadership of the people function and support the LFC to deliver its strategic objectives and manage the wide-ranging people and culture challenges.

4 Equality comments

- 4.1 The LFC and the Deputy Mayor for Planning, Regeneration and the Fire Service are required to have due regard to the Public Sector Equality Duty (section 149 of the Equality Act 2010) when taking decisions.
- 4.2 It is important to note that consideration of the Public Sector Equality Duty is not a one-off task. The duty must be fulfilled before taking a decision, at the time of taking a decision, and after the decision has been taken.

- 4.3 The protected characteristics are: age, disability, gender reassignment, pregnancy and maternity, marriage and civil partnership (but only in respect of the requirements to have due regard to the need to eliminate discrimination), race (ethnic or national origins, colour or nationality), religion or belief (including lack of belief), sex, and sexual orientation.
- 4.4 The Public Sector Equality Duty requires decision-takers in the exercise of all their functions, to have due regard to the need to:
 - eliminate discrimination, harassment and victimisation and other prohibited conduct.
 - advance equality of opportunity between people who share a relevant protected characteristic and persons who do not share it.
 - foster good relations between people who share a relevant protected characteristic and persons who do not share it.
- 4.5 Having due regard to the need to advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it involves havingdue regard, in particular, to the need to:
 - remove or minimise disadvantages suffered by persons who share a relevant protected characteristic where those disadvantages are connected to that characteristic.
 - take steps to meet the needs of persons who share a relevant protected characteristic that are different from the needs of persons who do not share it.
 - encourage persons who share a relevant protected characteristic to participate in publiclife or in any other activity in which participation by such persons is disproportionately low.
- 4.6 The steps involved in meeting the needs of disabled persons that are different from theneeds of persons who are not disabled include, in particular, steps to take account of disabled persons' disabilities
- 4.7 Having due regard to the need to foster good relations between persons who share a relevant protected characteristic and persons who do not share it involves having dueregard, in particular, to the need to:
 - tackle prejudice
 - promote understanding.
- 4.8 Korn Ferry were asked to identify candidates from diverse backgrounds using targeted networks and online advertising.
- 4.9 Overall, 48 candidates applied with all applicants submitting their diversity data. 44% declared themselves as male and 56% declared themselves as female and 27% candidates stated they were from an ethnic minority. Out of the four candidates that progressed to final interview, all 4 were female, one candidate stated that they were from an ethnic minority.
- 4.10 There is no evidence of the process having any adverse impact on those applicants with a protected characteristic.

5 Workforce comments

5.1 The respective representative bodies have been informed of the outcome of the recruitment process.

6 Sustainability comments

6.1 There are no sustainability comments.

7 Procurement comments

7.1 There are no direct procurement aspects in relation to this appointment recommendation. The provision of executive search support for this position was conducted in accordance with LFC governance/standard orders.

8 Communications comments

8.1 The appointment of the candidate will be communicated to the People directorate, and then to all staff.

9 Financial comments

9.1 This report seeks approval for the appointment of the Director for People. This post is part of the establishment in the People Directorate and the cost will be met from the existing directorate budget. The post formed part of the revised People Directorate structure outlined and approved in the LFC decision LFC-24-060x.

10 Legal comments

- 10.1 Section 1 of the Fire and Rescue Services Act 2004 states that the London Fire Commissioner is the fire and rescue authority for Greater London. Section 327A (5) of the Greater London Authority Act 1999 requires the Commissioner to secure that the London Fire and Rescue Service is efficient and effective. This means the personnel, services and equipment secured by the London Fire Commissioner for the purposes of carrying out the Commissioner's functions.
- 10.2 In accordance with Section 5A Fire and Rescue Services Act 2004 (FRSA 2004), the London Fire Commissioner, being a 'relevant authority', may do 'anything it considers appropriate for the purposes of the carrying out of any of its functions'. This is a matter coming within that power.
- 10.3 The appointment of an individual to a Director role as a permanent member of staff may amount to a decision under paragraph 3.1 c of the Mayoral Directions dated 2018 (matters that can reasonably be considered as novel, contentious or repercussive) and in such circumstances the Deputy Mayor for Planning, Regeneration and the Fire Service should be consulted. In this instance it was agreed by the Deputy Mayor that a senior officer of the GLA be a member of the interview panel.
