Request:

Fire safety engineering/ design strategies, emergencies access investments needed for delivering a safe overall urban design for this new London environment of higher risk towers packed like the City of London square mile, but covering many more square miles, of lower build quality and including many new towers sited on disconnected railway yard/junction severed-off 'bad' lands.

What engagement has LFB been allowed to help design highest quality fire safety infrastructure into this highest risk buildings massive scale Great Western City Growth,? As, I say this new City is already building in ad hoc fragments, taller and taller, more and more packed, more and more isolated and blocked-in.

Response:

In response, the London Fire Brigade (LFB) works with industry to support the development and building of safer homes, workplaces and places of entertainment, providing nearly 20,000 consultation responses to building and planning applications per year.
