Response:

Since 1st January 2017, 1-120 Bacton, NW5 4PU has had the following fire incidents and special services, which is detailed in the table below.

There have been three Fire Safety Audits, however one was cancelled. The Fire Safety Audits were carried out on the 16th April 2018, which resulted in a Notification of Deficiencies (NOD) and the other Audit was on the 20th July 2020. There have been no community fire safety visits for this address. Also, there have been no building control consultations during this time period.
