In case I didn't send this before, please see the document I referred to attached. The key lines of concern are as follows:

Lead concentration of 1600mg/kg at 1.2mgbl exceeding the GAC for commercial use of 750mc/kg.

Benzo(a)pyrene at 2.1mg/kg exceeding end use for residential of 1mg/kg

This implies that, in these areas, material exists which could pose a risk to human health in an industrial or residential end use scenario. Best.

Good to speak to you just now. This is our latest position on this ongoing issue. As mentioned, we are not aware of any report having been produced by our scientific advisors Bureau Veritas.

A London Fire Brigade spokesperson said: "Crews from Havering and surrounding boroughs have attended more than 70 fires at the site on Launders Lane in Rainham since 2018.

"The fires are distressing for the local community and are putting firefighters at unnecessary risk. The reason the fires are happening regularly is due to the build-up of heat from rubbish dumped at the site over a long period of time.

"Local communities deserve a long-term solution to the problem and we are part of a working group, alongside the council and the Environment Agency, that seeks to resolve this long-running issue.

"We will continue to send crews to assess the fire and we will respond appropriately so firefighters can ensure the fire does not spread any further."
